Sanction of **Science and Engineering Research Board (SERB)** is hereby accorded to the above mentioned project at a total cost of **Rs. 4718515/- (Rs. Forty Seven Lakh Eighteen Thousand Five Hundred and Fifteen Only)** with break-up of **Rs. 2266360/- under Capital (Non-recurring) head** and **Rs. 2452155/- under General (Recurring) head** for a duration of 36 months. - Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and general administrative support etc. including benefits to the staff employed in the project.
- While providing operational flexibility among various subheads under head Recurring-II, it should be ensured that not more than Rs. 1.5 lakh each should be spent for travel and contingency.

- The sanctioned equipment would be procured as per GFR and its disposal of the same would be done with prior approval of SERB.


